Explain: The 329-acre site contains features that have been evaluated for possible jurisdiction, including 2019 Wetland 1 (0.07 acre), 2019 Wetland 3 (0.04 acre), Wetland 3-NEW (0.03 acre), Wetland CL (0.59 acre), Wetland CO (0.72 acre), and Wetland CQ (0.52 acre).

The approved JD boundary includes 2019 Wetland 1, a 0.07 acre emergent wetland, 2019 Wetland 3, a 0.04 acre emergent wetland, Wetland 3-NEW, a 0.03 acre emergent wetland, Wetland CL, a 0.59 acre emergent wetland, Wetland CO, a 0.72 acre forested wetland, and Wetland CQ, a 0.52 acre emergent wetland. 2019 Wetland 1, 2019 Wetland 3, Wetland 3-NEW, Wetland CL, Wetland CO, and Wetland CQ exhibit no connectivity to any apparent stream channel or jurisdictional water of the United States. The closest jurisdictional stream to 2019 Wetland 1 is Stream 36, an unnamed tributary to Walnut Creek, which is located approximately 336 linear feet east of 2019 Wetland 1. The closest jurisdictional stream to 2019 Wetland 3 is Stream 36, an unnamed tributary to Walnut Creek, which is located approximately 416 linear feet east of 2019 Wetland 3. The closest jurisdictional stream to Wetland 3-NEW is Stream 39, an unnamed tributary to Walnut Creek, which is located approximately 710 linear feet south of Wetland 3-NEW. The closest jurisdictional stream to Wetland CL is Stream 35, an unnamed tributary to Walnut Creek, which is located approximately 575 linear feet east of Wetland CL. The closest jurisdictional stream to Wetland CO is Stream 37, an unnamed tributary to Walnut Creek, which is located approximately 760 linear feet south of Wetland CO. The closest jurisdictional stream to Wetland CQ is Stream 39, an unnamed tributary to Walnut Creek, which is located approximately 640 linear feet south of Wetland CQ. 2019 Wetland 1, 2019 Wetland 3, Wetland 3-NEW, Wetland CL, Wetland CO, and Wetland CQ would not support interstate or foreign commerce interests, nor do they contain any rare or endangered species. This office has determined that 2019 Wetland 1, 2019 Wetland 3, Wetland 3-NEW, Wetland CL, Wetland CO, and Wetland CQ are isolated, non-jurisdictional features, and not subject to regulation under Section 404 of the Clean Water Act (CWA).

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a

TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
