B. Typical year assessment(s): [A typical year occurs over a rolling thirty year period and includes the analysis of precipitation and other climatic variables to establish a normal period range \(seasonally or annually\) for a specific geographic region where the aquatic resource occurs. One point-in-time data sources, one for 17 March 2018, with a corresponding APT report, were included in the evaluation for the excluded Wet Areas 1 & 2 listed in Section II D. According to the APT report of March 2018, wetter than normal conditions were observed during the wet season with a PSDI Value of 3.1 \(severe wetness\) and an ARC score of 17. The antecedent precipitation condition is considered “wetter than normal” for that point in time. Additionally, based on the pictures submitted with the Report, during wetter than normal conditions in the wet season, Wet Area 1 and Wet Area 2 do not abut an \(a\)\(1\), \(a\)\(2\), or \(a\)\(3\) water, are not inundated by flooding from an \(a\)\(1\), \(a\)\(2\), or \(a\)\(3\) water in a typical year, and are not physically separated from an \(a\)\(1\), \(a\)\(2\), or \(a\)\(3\) water by a natural or artificial barrier. It has been determined that the non-adjacent wetlands listed in Section II D, above are not waters of the United States per 33 CFR 328.3\(b\)\(1\), and are not subject to regulation under Section 404.](#)
