- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain:

The ARCO Vandalia Area of Interest (AOI) is characterized predominately by row crops and a small cluster of buildings within the central area of the project. Roads, commercial developments, agriculture fields and the Dayton International Airport surround the 57 acre parcel AOI. On 30 March 2020, this office received a request for an approved jurisdictional determination (JD).

Based on a review of the previous report submitted to our office, and other data available to us, this office has determined that only non-jurisdictional waters are present within the approved JD boundary. The approved JD boundary contains one (1) isolated, non-jurisdictional wetland (0.9 acre).

Wetland 1 - (0.9 acre) is a depressional wetland that is located within an open field that has been subject to agricultural activities. The feature is depressional and surrounded entirely by uplands. Hydrology enters the features from rainfall runoff. The wetland does not possess a hydrologic surface or consolidated subsurface connection to a water of the U.S. Therefore, Wetland 1 is isolated, non-jurisdictional feature, not subject to regulation under Section 404 of the CWA.

The approved JD follows our 2 December 2008 headquarters guidance entitled "Revised Guidance on Clean Water Act Jurisdiction Following the United States Supreme Court Decision in *Rapanos v. United States and Carabell v. United States.*"

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is

the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
