B. Typical year assessment(s): A typical year occurs over a rolling thirty year period and includes the analysis of precipitation and other climatic variables to establish a normal period range (seasonally or annually) for a specific geographic region where the aquatic resource occurs. One point-in-time data sources, one for 7 February 2020, with a corresponding APT report, were included in the evaluation for the excluded wetlands listed in Section II D. According to the APT report of February 2020, wetter than normal conditions were observed during the wet season with a PSDI Value of 2.1 (moderate wetness) and an ARC score of 15. The antecedent precipitation condition is considered “wetter than normal” for that point in time. Additionally, during the based on the pictures submitted with the Report, during wetter than normal conditions in the wet season, supporting the fact that the wetlands do not abut an (a)(1), (a)(2), or (a)(3) water, is not inundated by flooding from an (a)(1), (a)(2), or (a)(3) water in a typical year, and is not physically separated from an (a)(1), (a)(2), or (a)(3) water by a natural or artificial barrier. It has been determined that the wetlands listed in Section II D, above, exhibits ephemeral flow, and is not a water of the United States per 33 CFR 328.3(b)(1), do not abut an (a)(1), (a)(2), or (a)(3) water, is not inundated by flooding from an (a)(1), (a)(2), or (a)(3) water in a typical year, and is not physically separated from an (a)(1), (a)(2), or (a)(3) water by a natural or artificial barrier and are not subject to regulation under Section 404.

C. Additional comments to support AJD: The wetlands are located outside of the 100 year floodplain. See Appendix A – FEMA FIRM Map in the Report.
