The Grand Lake St. Mary's Dam Rehabilitation Area of Interest (AOI) is comprised of an 18.7 acre AOI. The AOI consists of predominately forested area located at the toe of Grand Lake St. Mary's western embankment of the dam along the eastern portion of the AOI. The impoundment, Grand Lake St. Mary's, roads, commercial and residential developments, forested areas, and fallow fields surround the 18.7 acre AOI. On 29 April 2020, this office received a request for an approved jurisdictional determination (JD).

Based on a review of the previous report submitted to our office, and other data available to us, this office has determined that only non-jurisdictional waters are present within the approved JD boundary. The approved JD boundary contains one (1), non-jurisdictional swale (2,078 linear feet (lf)).

Swale SW-001 (2,078 lf) does not exhibit defined stream characteristics (e.g. OHWM, continuous bed and bank, sediment sorting, etc.) nor does it exhibit wetland characteristics. It was determined Swale SW-001 is a non-regulated water drainage and is a non-jurisdictional water of the United States.

Refer to the enclosed *Grand Lake St. Mary's Dam Rehabilitation Aquatic Resources – Approved JD Table*, and *Grand Lake St. Mary's Dam Rehabilitation Jurisdictional Determination Map* for a detailed summary of the non-jurisdictional features. The approved JD follows our 2 December 2008 headquarters guidance entitled "Revised Guidance on Clean Water Act Jurisdiction Following the United States Supreme Court Decision in *Rapanos v. United States* and *Carabell v. United States*."

If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
