- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain:

The Holden Gardens Residential Development Area of Interest (AOI) is characterized predominately by row crops and a small cluster of forested area in the western and southeastern area of the project. Roads, commercial and residential developments, and agriculture fields surround the approximate 65 acre parcel AOI. On 12 May 2020, this office received a request for a Department of Army permit along with a jurisdictional determination.

Based on a review of the previous report submitted to our office, and other data available to us, this office has determined that only non-jurisdictional waters are present within the approved JD boundaries. The two (2) approved JD boundaries contain three (3) isolated, non-jurisdictional wetlands (0.68 acre).

Wetland W01, W02 and W03 - (0.68 acre) are depressional wetlands that were farm ponds which were breached and drained between April 2007 and August 2009 based on Google Earth imagery. Wetland W01 is located in the northwestern portion of the project area. Wetlands W02 and W03 are located in the southeastern portion of the project area. These features are depressional and surrounded entirely by uplands. Hydrology enters the features from rainfall runoff. The wetlands do not possess a hydrologic surface or consolidated subsurface connection to a water of the U.S. Therefore, Wetland W01, W02, and W03 are isolated, non-jurisdictional features, not subject to regulation under Section 404 of the CWA.

The approved JD follows our 2 December 2008 headquarters guidance entitled "Revised Guidance on Clean Water Act Jurisdiction Following the United States Supreme Court Decision in *Rapanos v. United States and Carabell v. United States*."

C. **SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
