B. Typical year assessment(s): A typical year occurs over a rolling thirty year period and includes the analysis of precipitation and other climatic variables to establish a normal period range (seasonally or annually) for a specific geographic region where the aquatic resource occurs. One point-in-time data sources, one for 9 July 2020, with a corresponding APT report, were included in the evaluation for the excluded ephemeral stream listed in Section II D (Ditch). According to the APT report of July 2020, wetter than normal conditions were observed during the dry season with a PSDI Value of 1.62 (mild wetness) and an ARC score of 17. The antecedent precipitation condition is considered “wetter than normal” for that point in time. Additionally, during the based on the pictures submitted with the Report, during wetter than normal conditions in the dry season, little to no flow was observed, supporting the fact that the ephemeral stream does not meet the flow requirements of a jurisdictional tributary. It has been determined that the ephemeral stream listed in Section II D, above, exhibits ephemeral flow, and is not a water of the United States per 33 CFR 328.3(b)(3), and are not subject to regulation under Section 404.
