features (Storm Water Conveyance 1 and 2) and 3.92 acres of three (3) non-jurisdictional features (Pond A, Pond B, and Detention Basin 1) are located on the subject site. Based on a review of the information provided and other information available to us, the detention basin (2.24 acres), Ponds A (1.23 acres) and B (0.45 acre), and storm water conveyance channels 1 (254 linear feet) and 2 (1,835 linear feet) are dug wholly in uplands, is draining wholly uplands, and has less than relatively permanent flow. The aforementioned aquatic resources are not captured tributaries; are man-made drainage features that were constructed for discharging storm water away from the commercial facility and is evident in historical aerial imagery from 1968 and 1994. Therefore, Detention Basin 1, Ponds A and B, and Storm water Conveyance Channels 1 and 2, are not waters of the United States and is not subject to regulation under Section 404 of the Clean Water Act (CWA). ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
