jurisdictional wetlands (Wetlands A, B, F, G, H, I, J, K, L, M, and P). Wetlands A, B, F, G, H, I, J, K, L, M, and P were likely created as a result of agricultural activities and the development of the surrounding area. Wetlands A, B, F, G, H, I, J, K, L, M, and P are completely surrounded by uplands and have no distinct surface water connection to a water of the United States. The closest stream to Wetlands A and B is located 425 linear feet to the east/northeast. The closest Stream to Wetland F is located approximately 800 linear feet to the east. Wetlands H, I, J, and K are located approximately 640 linear feet south of the closest stream. Wetlands L and M are located approximately 275 linear feet south of the closest stream. Wetland P is located 800 linear feet east of the nearest stream. Wetlands A, B, F, G, H, I, J, K, L, M, and P would not support interstate or foreign commerce interests, nor do they contain any rare or endangered species. Swale 1 and Ditch 1 do not carry a relatively permanent flow of water, does not exhibit an ordinary high water mark or defined bed and bank or wetland characteristics. Swale 1 and Ditch 1 are discontinuous and heavily vegetated with upland herbaceous species in several locations. Storm Water Basin 1 appears to be man-made, excavated water feature created in uplands (not created by impoundment of a jurisdictional stream) to store, treat, and convey storm water and does not contain wetland vegetation. Therefore, Wetlands A, B, F, G, H, I, J, K, L, M, P, Storm Water Basin 1, Swale 1, and Ditch 1 are not waters of the United States and are not subject to regulation under Section 404 of the Clean Water Act (CWA).

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**
