B. Typical year assessment(s): A typical year occurs over a rolling thirty year period and includes the analysis of precipitation and other climatic variables to establish a normal period range (seasonally or annually) for a specific geographic region where the aquatic resource occurs. The antecedent precipitation tool was utilized to determine typical year for point-in-time data sources. Based on the antecedent precipitation tool, 8 April 2020 is included during the WebWIMP wet season and has a Palmer Drought Severity Index of mild wetness. The 30-day rolling total for precipitation was higher than the 30-year normal range. Therefore, site precipitation conditions are higher than the typical year conditions. Even at a higher than normal range, the ephemeral features were dry and are not considered jurisdictional features. Additionally, wetland adjacency was assessed through the 8 April 2020 point-in-time data sources. Even at a higher than normal precipitation conditions, the wetlands still had no adjacency and did not abut any (a)(2) streams. Section I (0.13 acre), Section II (0.27 acre), Section III (0.04 acre), Section IVA (0.05 acre), and Section IVB (0.008 acre) are not waters of the United States per 33 CFR 328.3 (b)(1).

C. Additional comments to support AJD: The project is located outside of the FEMA 100 year floodplain. There are no (a)(2) streams on-site.
