C. Additional comments to support AJD: "Hollow A" stream jurisdiction within the Area of Interest breaks at a point where water flows out of ground. Although NHD map data indicates possible intermittent stream located updrain of that point (which may or may not be hydrologically connected), that potential water is outside the Area of Interest.

Mapped ephemeral channel flows into ponded depression. No indicators found indicating any hydrologic connection (by conduit or rock drain) to Hollow A stream or other water of the U.S.
