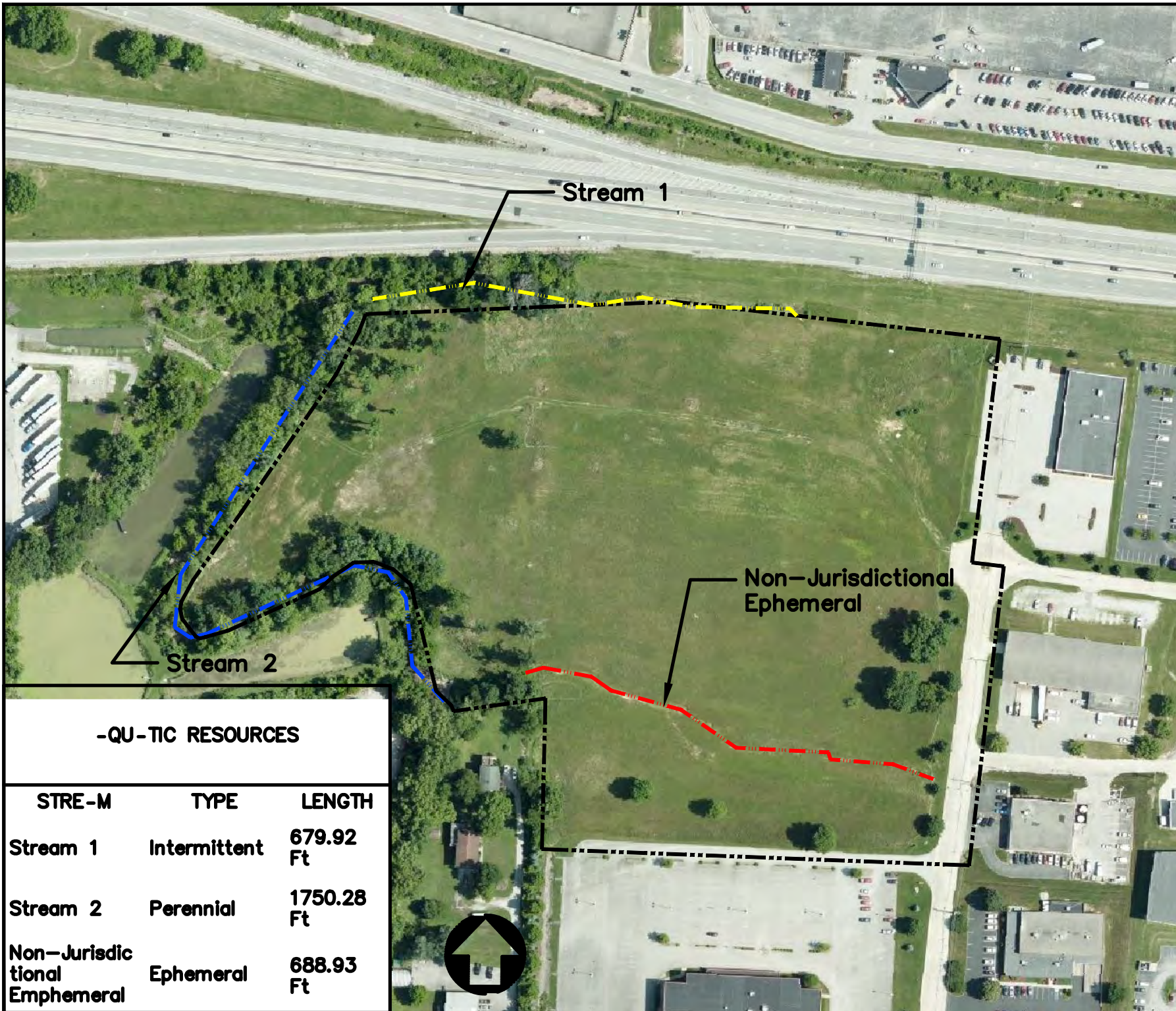
B. Typical year assessment(s): A typical year occurs over a rolling thirty-year period and includes the analysis of precipitation and other climatic variables to establish a normal periodic range (seasonally or annually) for a specific geographic region where the aquatic resource occurs. One (1) point-in-time data source for the site investigation conducted on 14 July 2020, with a corresponding Antecedent Precipitation Tool (APT) report, was included in the evaluation for the excluded ditch, Drainage Swale.

According to the APT report for July 2020, normal conditions were observed during the dry season with a Palmer Drought Severity Index (PDSI) Value indicating severe wetness. The antecedent precipitation condition with a score of 10 is considered “normal” for that point in time. Little to no flow was observed during the field investigation in July 2020.

The periodic range used for these typical year assessments was the three (3) 30-day periods preceding each observation date at nine (9) of the nearest available weather stations between two (2) and 15 miles of the AJD Review Area within the Lower Kanawha River watershed in Hydrologic Unit Code (HUC) 05050008. This geographic range is appropriate because it is the same 8-digit HUC as the aquatic resources within the geographic boundary of the AJD Review Area.

C. Additional comments to support AJD:

33 CFR 328.3(b)(5) - It has been determined that Drainage Swale, listed in Section II D above, exhibits ephemeral flow, is man-made feature constructed in uplands, and is not considered a water of the United States per 33 CFR 328.3(b)(5). Therefore, Drainage Swale is not subject to regulation under Section 404.
