**B. Typical year assessment(s):** A typical year occurs over a rolling thirty year period and includes the analysis of precipitation and other climatic variables to establish a normal period range (seasonally or annually) for a specific geographic region where the aquatic resource occurs. One point-in-time data source, one for 2 June 2020, with a corresponding APT report, was included in the evaluation for the excluded non-adjacent wetlands listed in Section II D. According to the APT report of June 2020, wetter than normal conditions were observed during the dry season with a PSDI Value of 2.81 (moderate wetness) and an ARC score of 13. The antecedent precipitation condition is considered “normal conditions” for that point in time. It has been determined that the non-adjacent wetlands listed in Section II D, above do not abut an (a)(1), (a)(2), or (a)(3) water, are not inundated by flooding from an (a)(1), (a)(2), or (a)(3) water in a typical year, and is not physically separated from an (a)(1), (a)(2), or (a)(3) water by a natural or artificial barrier, and are not waters of the United States per 33 CFR 328.3(b)(1), and are not subject to regulation under Section 404.

**C. Additional comments to support AJD:** The proposed project area is located outside of the 100 year floodplain. See Appendix C – Floodplain Map in the Report.
