B. Typical year assessment(s): A typical year occurs over a rolling thirty year period and includes the analysis of precipitation and other climatic variables to establish a normal period range (seasonally or annually) for a specific geographic region where the aquatic resource occurs. One point-in-time data source, 15 October 2020, with a corresponding APT report, were included in the evaluation the site. The antecedent precipitation tool was utilized to determine typical year for point-in-time data sources. Based on the antecedent precipitation tool, 15 October 2020 is included during the WebWIMP wet season and has a Palmer Drought Severity Index of 3.06 severe wetness. The 30-day rolling total for precipitation was within the 30-year normal range. Therefore, site conditions are within a typical year conditions and no aquatic

These four sub-categories are not new exclusions, but are simply administrative distinctions and remain (b)(1) exclusions as defined by the NWPR.

- C. Additional comments to support AJD:** On 15 October 2020, Corps representative, Jeremy Cochenour performed a site visit at the Harris Riverfront Park. The area was a mowed and maintained field with a mix of yard grass. The field was used for recreational purposes with benches, tables, and playgrounds intertwined. To the north of the site is the Ohio River and to the south is the floodwall. The area was previously disturbed by constructing the flood wall and park. A soil sample was taken during the site visit which did not produce hydrology and the soil was 7.5 YR 2.5/3. No additional indicators were observed.
