Typical year assessment(s): [A typical year occurs over a rolling 30-year period and includes the analysis of precipitation and other climatic variables to establish a normal period range \(seasonally or annually\) for a specific geographic region where the aquatic resource occurs. observed during the wet season with a PSDI Value of 1.75 (mild wetness) and an ARC score of 10. The antecedent precipitation condition is considered “normal” for that point in time. Additionally, during the based on the pictures submitted with the Report, during normal conditions in the wet season, no flow was observed, supporting the fact that the ephemeral stream does not meet the flow requirements of a jurisdictional tributary. It has been determined that the ephemeral stream listed in Section II D, above, exhibits ephemeral flow, and is not waters of the United States per 33 CFR 328.3(b)(3), and is not subject to regulation under Section 404.
