Tool (APT) report, were included in the evaluation for the excluded wetlands listed in Section II D Stream 1.

According to the APT report for 3 December 2020, normal conditions were observed during the dry season with a Palmer Drought Severity Index (PDSI) Value of 1.24 (mild wetness). The antecedent precipitation condition with a score of 11 is considered "normal" for that point in time.

The periodic range used for these typical year assessments was the three (3) 30-day periods preceding each observation date at the nearest available weather station at Parkersburg Airport, approximately 1.0 mile west of the AJD Review Area within the Upper Ohio watershed in Hydrologic Unit Code (HUC) 05030203. This geographic range is appropriate because it is the same 8-digit HUC as the aquatic resources within the geographic boundary of the AJD Review Area.

C. Additional comments to support AJD: 33 CFR 328.3(b)(3) - It has been determined that Stream 1, listed in Section II D above, exhibits ephemeral flow and is not considered a water of the United States per 33 CFR 328.3(b)(3). Therefore, Stream 1 is not subject to regulation under Section 404.
