B. Typical year assessment(s): A typical year occurs over a rolling thirty year period and includes the analysis of precipitation and other climatic variables to establish a normal period range (seasonally or annually) for a specific geographic region where the aquatic resource occurs. One point-in-time data sources, one for 18 November 2020, with a corresponding APT report, were included in the evaluation for the excluded ephemeral streams listed in Section II D (Stream 1 and Stream 2). According to the APT report of November 2020, normal conditions were observed during the wet season with a PSDI Value of 1.87 (mild wetness) and an ARC score of 14. The antecedent precipitation condition is considered “normal” for that point in time. Additionally, during the based on the pictures submitted with the Report, during normal conditions in the wet season, little to no flow was observed, supporting the fact that the ephemeral streams do not meet the flow requirements of a jurisdictional tributary. It has been determined that the ephemeral streams listed in Section II D, above, exhibits ephemeral flow, and are not a water of the United States per 33 CFR 328.3(b)(3), and are not subject to regulation under Section 404.
