**B. Typical year assessment(s):** [A typical year occurs over a rolling 30-year period and includes the analysis of precipitation and other climatic variables to establish a normal period range \(seasonally or annually\) for a specific geographic region where the aquatic resource occurs. One \(1\) point-in-time data source, 23 September 2020 \(Dry Season\), with a corresponding APT report, were included in the evaluation of the site. The antecedent precipitation tool was utilized to determine typical year for point-in-time data sources. Potential wetland and stream identification was assessed on 23 September 2020. Based on the antecedent precipitation tool, 23 September 2020 is included during the WebWIMP dry season and has a](#)

These four sub-categories are not new exclusions, but are simply administrative distinctions and remain (b)(1) exclusions as defined by the NWPR.

Palmer Drought Severity Index of 1.49 mild wetness. The 30-day rolling total for precipitation was within the 30-year normal range. Therefore, site conditions appeared to be within a typical year. The ephemeral feature had no flow at the time of investigation. There are no wetlands located on-site.

**C. Additional comments to support AJD:** The entire 21-acre AJD boundary is outside of the FEMA Floodplain.
