**B. Typical year assessment(s):** *A typical year occurs over a rolling 30-year period and includes the analysis of precipitation and other climatic variables to establish a normal period range (seasonally or annually) for a specific geographic region where the aquatic resource occurs. One (1) point-in-time data source, 7 October 2020 (Wet Season), with a corresponding APT report, were included in the evaluation of the site. The antecedent precipitation tool was utilized to determine typical year for point-in-time data sources. Potential wetland identification was assessed on 7 October 2020. Based on the antecedent precipitation tool, 7 October 2020 is included during the WebWIMP wet season and has a Palmer Drought Severity Index of 2.03 moderate wetness. The 30-day rolling total for precipitation was within the 30-year normal range. Therefore, site conditions appeared to be within a typical year. The ephemeral features had no flow at the time of investigation and do not connect to a (a)(1)-(a)(2) water. Additionally, the on-site wetlands had no connection to an (a)(1)-(a)(2) water.*

**C. Additional comments to support AJD:** *The entire 169-acre AJD boundary is outside of the FEMA Floodplain.*
