- B. Typical year assessment(s):** A typical year occurs over a rolling thirty year period and includes the analysis of precipitation and other climatic variables to establish a normal period range (seasonally or annually) for a specific geographic region where the aquatic resource occurs. One point-in-time data sources, one for 8 March 2021, with a corresponding APT report, were included in the evaluation for the jurisdictional streams listed in Section II D (Streams 1-2). According to the APT report of March 2021, drier than normal conditions were observed during the wet season with a PSDI Value of 1.14 (mild drought) and an ARC score of 7. The antecedent precipitation condition is considered “drier than normal” for that point in time. Streams 1-2 exhibited flow within the stream channel which corresponds with the APT report conditions. Streams 1-2 contribute intermittent flow downstream indirectly to the Scioto River, an (a)(1) water in a typical year. Therefore, Streams 1-2 are (a)(2) waters.
