Explain: **The project site contains four (4) wetlands (Wetlands A-D) comprising 0.26 acre. These wetlands appear to be driven by precipitation, are surrounded by uplands, and lack an apparent surface hydrological connection to a surface tributary system. The closest surface tributary (an unnamed**

tributary to Big Walnut Creek on the eastern portion of the property) is approximately 615 feet away from Wetlands A-D. In addition to being hydrologically isolated from a surface water tributary system, these wetlands do not appear to support interstate of foreign commerce interests nor do they contain any rare or endangered species. Based on this information, Wetlands A-D are isolated wetlands and are not jurisdictional waters of the United States. In addition, there is one (1) ditch (Ditch 1) and one (1) swale (Swale 1) located within the property boundary that do not exhibit a relatively permanent flow of water and lacked a defined bed, bank, or ordinary high water mark. Ditch 1 and Swale 1 are not considered to be waters of the United States and are not subject to Section 404.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
