B. Typical year assessment(s): [A typical year occurs over a rolling thirty year period and includes the analysis of precipitation and other climatic variables to establish a normal period range \(seasonally or annually\) for a specific geographic region where the aquatic resource occurs. One point-in-time data source, 12 January 2021 \(Wet Season\), with a corresponding APT report, were included in the evaluation of the site. The antecedent precipitation tool was utilized to determine typical year for point-in-time data sources. Potential wetland identification was assessed on 12 January 2021. Based on the antecedent precipitation tool, 12 January 2021 is included during the WebWIMP wet season and has a Palmer Drought Severity Index of -0.81 incipient drought. The 30-day rolling total for precipitation was within the 30-year normal range. Therefore, site conditions appeared to be within a typical year.](#)

C. Additional comments to support AJD: [A small portion of the northwest section of the AJD boundary is locating in Zone A \(1% annual Chance Flood Hazard\) and floodway of the FEMA Floodplain. The only feature located with these areas is Patzer Ditch an \(a\)\(2\) perennial stream.](#)
