- B. Typical year assessment(s):** A typical year occurs over a rolling thirty year period and includes the analysis of precipitation and other climatic variables to establish a normal period range (seasonally or annually) for a specific geographic region where the aquatic resource occurs. One point-in-time data source, 11 March 2021 (Wet Season), with a corresponding APT report, were included in the evaluation of the site. The antecedent precipitation tool was utilized to determine typical year for point-in-time data sources. Potential wetland and stream identification was assessed on 11 March 2021. Based on the antecedent precipitation tool, 11 March 2021 is included during the WebWIMP wet season and has a Palmer Drought Severity Index of -1.13 mild drought. The 30-day rolling total for precipitation was within the 30-year normal range. Therefore, site conditions appeared to be within a typical year. The ephemeral feature had no flow at the time of investigation and Wetland B had no connection to an (a)(1)-(a)(2) water.
- C. Additional comments to support AJD:** The southern half of the AJD boundary is located within both the Floodway and Zone A (1% chance of flooding) while the rest of the site is outside of the FEMA Floodplain.
