- B. Typical year assessment(s):** A typical year occurs over a rolling thirty year period and includes the analysis of precipitation and other climatic variables to establish a normal period range (seasonally or annually) for a specific geographic region where the aquatic resource occurs. One point-in-time data source, 1 March 2021 (Wet Season), with a corresponding APT report, were included in the evaluation of the site. The antecedent precipitation tool was utilized to determine typical year for point-in-time data sources. Potential wetland and stream identification was assessed on 1 March 2021. Based on the antecedent precipitation tool, 1 March 2021 is included during the WebWIMP wet season and has a Palmer Drought Severity Index of -1.13 mild drought. The 30-day rolling total for precipitation was just slightly drier than the 30-year normal range. The wetlands do not abut to a (a)(1)-(a)(2) or meet the definition of an adjacent wetland. No streams are located within the 6-acre AJD Boundary.
- C. Additional comments to support AJD:** The enire 6-acre AJD boundary is outside of the FEMA Floodplain.
