B. Typical year assessment(s): A typical year occurs over a rolling thirty year period and includes the analysis of precipitation and other climatic variables to establish a normal period range (seasonally or annually) for a specific geographic region where the aquatic resource occurs. One point-in-time data source, 30 March 2021 (Wet Season), with a corresponding APT report, were included in the evaluation for the excluded features onsite. The antecedent precipitation tool was utilized to determine typical year for point-in-time data sources. Wetland and stream identification was assessed on 30 March 2021. Based on the antecedent precipitation tool, 30 March 2021 is included during the WebWIMP wet season and has a Palmer Drought Severity Index of -1.13 mild drought. The 30-day rolling total for precipitation was within the 30-year normal range. Therefore, site conditions appeared to be within a typical year. Streams 1 and 2 still only showed ephemeral flow and non-jurisdictional. Wetland A still had no connection to a jurisdictional water. Additionally, Pond 1 had no connection to an (a)(1)-(a)(2) water.
