B. Typical year assessment(s): A typical year occurs over a rolling thirty-year period and includes the analysis of precipitation and other climatic variables to establish a normal period range (seasonally or annually) for a specific geographic region where the aquatic resource occurs. One (1) point-in-time data source dated 22 December 2020, with a corresponding antecedent precipitation tool (APT) report, is included in the evaluation for the features listed in Section II D, as applicable. According to the APT report for 22 December 2020, normal conditions with an antecedent condition calculation of 11 were observed during the WebWIMP wet season with a Palmer Drought Severity Index Value of incipient wetness. The 30-day rolling total for precipitation was within the 30-year normal range. Based on the submitted information, Wetlands A-F do not abut a water identified in 33 CFR 328.3(a)(1), (2), or (3), are not inundated by flooding from a water identified in 33 CFR 328.3(a)(1), (2), or (3) in a typical year, are not physically separated from a water identified in 33 CFR 328.3(a)(1), (2), or (3) only by a natural berm, bank, dune, or similar natural feature, and are not physically separated from a water identified in 33 CFR 328.3(a)(1), (2), or (3) only by an artificial dike, barrier, or similar

artificial structure. Therefore, Wetlands A-F are not jurisdictional waters of the United States per 33 CFR 328.3(b)(1).

- C. Additional comments to support AJD:** Based on aerial imagery, Pond 1 was constructed in uplands between 1988-2002. Pond 1 is not an impoundment of an (a)(1)-(a)(3) water and is not a jurisdictional water of the United States per 33 CFR 328.3(b)(8). Based on aerial imagery, Ditch 1 was constructed in uplands between 1988-2002. Ditch 1 does not relocate a tributary, was not constructed in a tributary, and was not constructed in an adjacent wetland. Ditch 1 is not a jurisdictional water of the United States per 33 CFR 328.3(b)(5). Based on the submitted information, Swales 1 and 2 exhibit ephemeral flow. Therefore, Swales 1 and 2 are not jurisdictional waters of the United States per 33 CFR 328.3(b)(3). According to the National Flood Hazard FEMA map, the site is not located within a flood hazard area.
