Based on a review of the supplemental information report received in this office on August 17, 2016 , a desktop review of the location, an on-site investigation and other data available to us, this office has determined that one non-jurisdictional ephemeral stream (UNT 1A Elk Creek) is located within the area of interest (AOI). UNT 1A Elk Creek is an isolated ephemeral stream and has no hydrological connection to a surface tributary stream. In addition to being hydrologically isolated from a surface tributary system, UNT 1A Elk Creek does not support interstate or foreign commerce interests. The property surrounding both wetlands exhibits post mining operations along with existing gas well roads and ATV trails.

Based on the above referenced information, this office has determined that UNT 1A Elk Creek is an isolated, non-jurisdictional feature, and is not subject to regulation under Section 404 of the Clean Water Act. The aforementioned non-jurisdictional determination is based on guidance that became effective on 29 May 1998. This guidance was the result of the U.S. v. Wilson, 133 F. 3d 251 (4th Cir. 1997).

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:
