- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: Approximately 3,357 linear feet of eight (8) isolated ephemeral channels and one (1) isolated palustrine emergent (PEM) wetland (Wetland 2) totaling 0.003 acre were observed within the area of interest. The ephemeral channels (NJD 2, 3, 4, 5, 6, 7, 8, and 9) showed no signs of leaf and debris disturbance and no hydrologic surface or consolidated subsurface connection to a surface tributary system. The ephemeral channels did not exhibit an ordinary high water mark, a defined bed and bank or deep ravines with rocky outcrops and appeared to be part of past SMCRA mining activity in conjunction with a refuse dump. The isolated PEM wetland was completely surrounded by uplands and did not present a hydrologic connection to a surface tributary stream and was established due to past equipment work to an existing nature gas pipeline. Both the wetland and ephemeral channels did not exhibit a hydrologic surface or consolidated subsurface connection to waters of the U.S. Therefore, these features are not considered jurisdictional waters of the U.S. and are not subject to regulation under Section 404 of the Clean Water Act.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. **C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
