Explain: **Based on a review of the information provided and other information available to us, the approximate 209 acre study area contains four (4) geographically isolated, non-jurisdictional wetlands (Wetlands A, B, E, and F). Wetlands A, B, E, and F were likely created as a result of development and**

agricultural activities in the surrounding area. Wetlands A, B, E, and F are completely surrounded by uplands and have no distinct surface water connection to a water of the United States. The closest stream to Wetland E is approximately 830 linear feet northwest and approximately 1,760 linear feet south of Wetland B. Wetlands A, B, E, and F would not support interstate or foreign commerce interests, nor do they contain any rare or endangered species. Therefore, Wetlands A, B, E, and F are not considered jurisdictional waters of the United States.

The site also contains Swales 1-10 (approximately 2,372 linear feet) and Channels 1- 2 (approximately 579 linear feet). The swales and channels were likely created as a result of agricultural activities and have no surface water connections to waters of the United States. Swales 1-10 do not carry a relatively permanent flow of water, and do not exhibit an ordinary high water mark or defined bed and bank or wetland characteristics. Channels 1-2 do not carry a relatively permanent flow of water and lack a traceable connection to a jurisdictional water. Therefore, Swales 1-10, and Channels 1-2 are not considered jurisdictional waters of the United States.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
