Explain: The approved jurisdictional determination (JD) boundary contains one (1) isolated wetland, Wetland A, totaling 0.65 acre. Wetland A is dominated by red maple (*Acer rubrum*), silver maple (*Acer saccharum*), northern catalpa (*Catalpa speciosa*), glossy buckthorn, (*Frangula alnus*), jumpseed (*Persicaria virginiana*), and Virginia creeper (*arthenocissus*

*quinquefolia*). Wetland hydrology indicators included water-stained leaves, drainage patterns, and geomorphic position. The nearest tributary is located over 1.5-aerial miles from Wetland A. The wetland is surrounded by uplands, and residential development. There are no swales, ditches, pipes, storm drains or other discrete and confined surface water conveyance that would provide a surface hydrological connection to another water of the U.S.

No evidence of subsurface flow was documented in the materials submitted by the agent. The wetland has been determined to not have a surface or shallow subsurface hydrologic connection to any navigable waters or their tributaries. Based upon a review of aerial photographs, the U.S Geological Survey (USGS) 7.5 Minute Quadrangle, the National Hydrography Dataset (NHD), the National Wetland Inventory (NWI) maps, topographic data (USGS Quad map), and the materials submitted by the agent, Wetland A has been determined to be hydrologically isolated with no surface water connection to a water of the U.S.

Wetland A does not support a link to interstate or foreign commerce because the wetland is not known to be used by interstate or foreign travelers for recreation or other purposes. The wetland does not produce fish or shellfish that could be taken and sold in interstate or foreign commerce. The wetland is not known to be used for industrial purposes by industries in interstate or foreign commerce. Wetland A has been determined to not be a water of the U.S. and is therefore not jurisdictional under the Section 404 of the Clean Water Act (CWA).

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
