Open water Pond WI-2 (0.03 acre), Wetland WLD (0.47 acre), and Wetland WLE (0.01 acre) are located within closed depressions situated on a reclaimed surface coal mine site. Based on the submitted information and other information available to us, the Corps determined open water Pond WI-2, Wetland WLD, and Wetland WLE are hydrologically isolated from the surface tributary system. The aquatic resources are completely surrounded by uplands, exhibit no evidence of a hydrological connection to a water of the United States, and no apparent connection with interstate or foreign commerce or use for any irrigation purposes, nor do they contain any rare or endangered species. Therefore open water Pond WI-2, Wetland WLD, and Wetland WLE are isolated, non-jurisdictional features, and not subject to regulation under Section 404 of the Clean Water Act (CWA).

The approved JD follows our 2 December 2008 headquarters guidance entitled "Revised Guidance on Clean Water Act Jurisdiction Following the United States Supreme Court Decision in *Rapanos v. United States* and *Carabell v. United States*."

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a

TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
