The approved jurisdictional determination (JD) boundary contains two (2) isolated wetlands, Wetland A and Wetland D.

Wetland A (0.018 acre) and Wetland D (0.030 acre) are emergent wetlands located in an existing pipeline right-of-way (ROW) that formed as a result of construction of the pipeline. The wetlands receive hydrology from precipitation and runoff; no surface water is present in the wetlands in photographs provided by the applicant. Wetland A is located approximately 150 linear feet from the nearest stream and Wetland D is located approximately 540 linear feet from the nearest stream. The wetlands are surrounded by uplands, primary the existing pipeline ROW, and forested areas. There are no swales, ditches, pipes, storm drains or other discrete and confined surface water conveyance that would provide a surface hydrological connection to another water of the United States (WOUS)

No evidence of subsurface flow was documented in the materials submitted by the agent. The wetlands have been determined to not have a surface or shallow subsurface hydrologic connection to any navigable waters or their tributaries. Based upon a review of aerial photographs, the USGS 7.5 Minute Quad, the National Hydrography Dataset (NHD), the National Wetland Inventory (NWI) maps, topographic data (USGS Quad map), and the materials submitted by the agent, Wetlands A and D have been determined to be hydrologically isolated with no surface water connection to a WOUS.

Wetlands A and D do not support a link to interstate or foreign commerce because the wetlands are not known to be used by interstate or foreign travelers for recreation or other purposes. The wetlands do not produce fish or shellfish that could be taken and sold in interstate or foreign commerce. The wetlands are not known to be used for industrial purposes by industries in interstate or foreign commerce. Wetlands A and D have been determined to not be WOUS and are therefore not jurisdictional under the Section 404 of the Clean Water Act. The aforementioned non-jurisdictional determination is based on guidance that became effective on 29 May 1998. This guidance was the result of the *United States v. Wilson*, 133 F. 3d 251 (4th Cir. 1997).

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
