The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that directly abuts an RPW is also jurisdictional. If the aquatic resource is not a TNW, but has year-round (perennial) flow, skip to Section III.D.2. A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Stream 3/3B is one stream channel that changes flow regime as it progresses downstream. Stream 3/3B includes 717 lf of ephemeral stream on the upstream end and 357 lf perennial stream on the downstream end. Stream 3/3B will be evaluated as a non-RPW. Stream 3/3B conveys storm water and surface runoff to the tributary system via Stream 10/8A/8B to Crooked Creek. Additionally, a portion of Stream 3/3B conveys surface water year round to the tributary system via Stream 10/8A/8B. Ephemeral streams reduce the pollution that flows downstream by retaining sediments and excess nutrients, and ephemeral streams also have the ability to provide nutrients and organic carbon that support foodwebs for plants and wildlife downstream. Ephemeral streams store nutrients in the form of detrital material that is carried into the receiving tributaries during precipitation events. This detrital material is a critical resource to many macro- and microorganisms that form the basis of the food chain in aquatic systems. Stream 3/3B has the capacity to carry pollutants or flood waters to the receiving TNW and/or has the capacity to reduce the amount of pollutants or floodwaters reaching the receiving TNW. Stream 3/3B also has the capacity to transfer nutrients and organic carbon that support downstream foodwebs. Stream 3/3B is an indirect tributary to the Kanawha River and provides more than a minimal or insubstantial effect on the chemical, physical and biological integrity of the receiving TNW, the Kanawha River.
