- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain:

An on-site field investigation was conducted on August 30, 2016 and September 30, 2016. The site has been previously disturbed by pre-law coal mining activities. According to the Ohio Department of Natural Resources - Mines of Ohio Viewer, the site was surface mined prior to 1972. Mining related features observed on-site include un-reclaimed highwalls, excavated pits, spoil material, constructed berms, mining benches and access/haul roads. The site has also been affected by timber removal activities. A review of historical mapping indicates PP-F, PP-F WLD Fringe, PP-H, PP-H WLD Fringe, PP-I, PP-J, PP-J WLD Fringe, and PP-S are features created as a result of the excavation associated with mining activities.

The ponds and wetlands identified as PP-F, PP-F WLD Fringe, PP-H, PP-H WLD Fringe, PP-I, PP-J, PP-J WLD Fringe, and PP-S were inspected during the field investigation. The aquatic resources are located in closed depressions (excavated pits) subject to ponding water from precipitation and seepage from the highwall and auger holes. Wetlands PP-F WLD Fringe, PP-H WLD Fringe, PP-I, PP-J WLD Fringe, and PP-S are low quality herbaceous wetlands that have developed in and along the perimeter of the excavated pits/ponds. Based on the field investigation, the Corps determined ponds PP-F, PP-H, PP-J and wetlands PP-F WLD Fringe, PP-H WLD Fringe, PP-I, PP-J WLD Fringe, and PP-S are hydrologically isolated from the surface tributary system.

These ponds and wetlands are completely surrounded by uplands, exhibit no evidence of a hydrological connection to a water of the United States, and no apparent connection with interstate or foreign commerce or use for any irrigation purposes nor do they contain any rare or endangered species. Based on this information, ponds PP-F, PP-H, PP-J and wetlands PP-F WLD Fringe, PP-H WLD Fringe, PP-I, PP-J WLD Fringe, and PP-S are not jurisdictional waters of the United States.

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
