land surrounding this wetland consists of open meadow fields. This feature does not have a distinct surface water connection to another potential water of the United States. The closest jurisdictional stream is approximately 500 feet away. This feature would not support interstate or foreign commerce interest, nor does it contain any rare or threatened and endangered species. Therefore, this feature is not a jurisdictional water of the United States. Wetland B (0.21 acre) located in the eastern portion of the property is completely surrounded by uplands, with no surface water connection to a water of the United States, and no nexus to interstate or foreign commerce. The land surrounding this wetland consists of open meadow fields. This feature does not have a distinct surface water connection to another potential water of the United States. The closest jurisdictional stream is approximately 1,200 feet away. This feature would not support interstate or foreign commerce interest, nor does it contain any rare or threatened and endangered species. Therefore, this feature is not a jurisdictional water of the United States. Wetland C (0.03 acre) located in the eastern portion of the property is completely surrounded by uplands, with no surface water connection to a water of the United States, and no nexus to interstate or foreign commerce. The land surrounding this wetland consists of open meadow fields. This feature does not have a distinct surface water connection to another potential water of the United States. The closest jurisdictional stream is approximately 650 feet away. This feature would not support interstate or foreign commerce interest, nor does it contain any rare or threatened and endangered species. Therefore, this feature is not a jurisdictional water of the United States. Wetland E (0.03 acre) located in the central portion of the property is completely surrounded by uplands, with no surface water connection to a water of the United States, and no nexus to interstate or foreign commerce. The land surrounding this wetland consists of open meadow fields. This feature does not have a distinct surface water connection to another potential water of the United States. The closest jurisdictional stream is approximately 570 feet away. This feature would not support interstate or foreign commerce interest, nor does it contain any rare or threatened and endangered species. Therefore, this feature is not a jurisdictional water of the United States. Wetland F (0.18 acre) located in the central portion of the property is completely surrounded by uplands, with no surface water connection to a water of the United States, and no nexus to interstate or foreign commerce. The land surrounding this wetland consists of open meadow fields. This feature does not have a distinct surface water connection to another potential water of the United States. The closest jurisdictional stream is approximately 540 feet away. This feature would not support interstate or foreign commerce interest, nor does it contain any rare or threatened and endangered species. Therefore, this feature is not a jurisdictional water of the United States. Wetland G (0.29 acre) located in the western portion of the property is completely surrounded by uplands, with no surface water connection to a water of the United States, and no nexus to interstate or foreign commerce. The land surrounding this wetland consists of open meadow fields. This feature does not have a distinct surface water connection to another potential water of the United States. The closest jurisdictional stream is approximately 1,130 feet away. This feature would not support interstate or foreign commerce interest, nor does it contain any rare or threatened and endangered species. Therefore, this feature is not a jurisdictional water of the United States. Channel 1 (129 linear feet) forms naturally within the eastern portion of the subject site. The feature flows in a southeastern direction for approximately 129 linear feet before its defined features diminish and discharge into a maintained lawn. It was determined that this feature lacks a continuous surface water connection to tributary systems of a traditional navigable water. Therefore, this feature does not meet the criteria of a water of the United States in accordance with the definitions outlined in 33 CFR 328.3(a). Channel 2 (413 linear feet) forms naturally within the eastern portion of the subject site. The feature flows in a southeastern direction for approximately 413 linear feet before discharging into an isolated wetland (Wetland A). It was determined that this feature lacks a continuous surface water connection to tributary systems of a traditional navigable water. Therefore, this feature does not meet the criteria of a water of the United States in accordance with the definitions outlined in 33 CFR 328.3(a). Channel 3 (86 linear feet) forms naturally within the northern portion of the subject site. The feature flows in a southern direction for approximately 86 linear feet before its defined features diminish and it discharges into a discharging into an agricultural field. It was determined that this feature lacks a continuous surface water connection to tributary systems of a traditional navigable water. Therefore, this feature does not meet the criteria of a water of the United States in accordance with the definitions outlined in 33 CFR 328.3(a). Channel 4 (105 linear feet) forms naturally within the western portion of the subject site. The feature flows in a southwestern direction for approximately 105 linear feet before becoming Swale 2. It was determined that this feature lacks a continuous surface water connection to tributary systems of a traditional navigable water. Therefore, this feature does not meet the criteria of a water of the United States in accordance with the definitions outlined in 33 CFR 328.3(a). Channel 4 (105 linear feet) forms naturally within the western portion of the subject site. The feature flows in a southwestern direction for approximately 105 linear feet before becoming Swale 2. It was determined that this feature lacks a continuous surface water connection to tributary systems of a traditional navigable water. Therefore, this feature does not meet the criteria of a water of the United States in accordance with the definitions outlined in 33 CFR 328.3(a).

Three upland vegetated drainageways (Swale 1, Swale 2, Swale 3, Swale 4, Swale 5, and Swale 6) are present within the site. Swale 1, Swale 2, Swale 3, Swale 4, Swale 5, and Swale 6 are located in uplands, lacks a defined bed and bank, and ordinary high water mark (OHWM), therefore they are not waters of the United States. .

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that directly abuts an RPW is also jurisdictional. If the aquatic resource is not a TNW, but has year-round (perennial) flow, skip to Section III.D.2. If the aquatic resource is a wetland directly abutting a tributary with perennial flow, skip to Section III.D.4.

A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. Corps districts and EPA regions will include in the record any available information that documents the existence of a significant nexus between a relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. If the JD covers a tributary with adjacent wetlands, complete Section III.B.1 for the tributary, Section III.B.2 for any onsite wetlands, and Section III.B.3 for all wetlands adjacent to that tributary, both onsite and offsite. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

- Does the tributary, in combination with its adjacent wetlands (if any), have the capacity to carry pollutants or flood waters to TNWs, or to reduce the amount of pollutants or flood waters reaching a TNW?
