**B. Typical year assessment(s):** A typical year occurs over a rolling thirty year period and includes the analysis of precipitation and other climatic variables to establish a normal period range (seasonally or annually) for a specific geographic region where the aquatic resource occurs. One (1) point-in-time data source dated 7 May 2021, with a corresponding antecedent precipitation tool (APT) report, are included in the evaluation for the excluded features listed in Section II D. According to the APT report for 7 May 2021, normal conditions with an antecedent precipitation condition score of -11 was observed during the WebWIMP wet season with a Palmer Drought Severity Index Value of 0.0 normal, wet season. The 30-day rolling total for precipitation was within the normal rolling thirty year period.
