Isolated Wetland Determinations:

Wetlands A, B, F, and G, totaling 1.71 acres, are located within isolated depressions where overland flow collects from the surrounding area. Each of the isolated wetlands features was likely created and heavily influenced by the development and maintenance activities associated with the Cumberland Trails Golf Club. No tributaries, channels, inflow/outflow structures or evident surface water connections exist linking the wetlands to a surface tributary system of the United States. Wetlands A, B, F and G are surrounded by uplands, have no ties to interstate and foreign commerce, and are not directly connected to, located adjacent to, or abutting a non-relatively permanent water in such a way as to exhibit a significant nexus with a traditional navigable water (TNW) of the United States. Wetlands A, B, F and G are located on private property, do not support commercial fish species, and are not used for agricultural irrigation. Based on the absence of a surface hydrological connection, or adjacency to a water of the United States, Wetlands A, B, F and G have been determined to be isolated, are not considered jurisdictional waters of the United States, and are not subject to regulation under Section 404 of the Clean Water Act.

Non-Jurisdictional Determinations:

Swales 1, 2, and 3, totaling 1,572 linear feet, do not exhibit relatively permanent flows of water and lack defined beds and banks, an ordinary high water mark, or wetland characteristics (Enclosure 4). Swales 1, 2, and 3 are non-jurisdictional anthropogenic drainage features excavated to aid golf course irrigation and do not possess the characteristics of a tributary or a wetland. Swales 1, 2, and 3 are not considered to be jurisdictional waters of the United States and are not subject to regulation under Section 404 of the Clean Water Act.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
