project site. These wetlands are located within a forested area in the eastern portion of the site and are located in depressions. There are no apparent stream or hydrologic connections to the tributary system. There was no indication that any of the wetlands overflowed into surrounding areas. These wetlands were determined to be isolated with no hydrologic connection to the tributary system and no substantial nexus to interstate or foreign commerce. These wetlands are located in uplands, surrounded by uplands and lack a surface water connection to the tributary system of the Scioto River . Wetlands A and B are not considered a water of the United States and are non-jurisdictional (Isolated) wetlands.

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

These wetlands are located within a forested area in the eastern portion of the site and are located in depressions. There are no apparent stream or hydrologic connections to the tributary system. There was no indication that any of the

wetlands overflowed into surrounding areas. These wetlands were determined to be isolated with no hydrologic connection to the tributary system and no substantial nexus to interstate or foreign commerce. These wetlands are located in uplands, surrounded by uplands and lack a surface water connection to the tributary system of the Scioto River . Wetlands A and B are not considered a water of the United States and are non-jurisdictional (Isolated) wetlands.
