land surrounding this wetland consists of secondary growth forested area. This feature does not have a distinct surface water connection to another potential water of the United States. The closest jurisdictional stream is approximately 120 feet away. This feature would not support interstate or foreign commerce interest, nor does it contain any rare or threatened and endangered species. Therefore, this feature is not a jurisdictional water of the United States.

Wetland B (0.08 acre) located in the western portion of the property is completely surrounded by uplands, with no surface water connection to a water of the United States, and no nexus to interstate or foreign commerce. ### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**
