**Wetland 1 is a 0.317 acre emergent wetland located on site. Wetland 1 exhibits no connectivity to any apparent stream channel or jurisdictional water of the United States. The closest jurisdictional stream is an unnamed tributary to the Scioto River that is located**

approximately 1,780 linear feet southeast of Wetland 1. Wetland 1 would not support interstate or foreign commerce interests, nor does it contain any rare or endangered species. This office has determined that Wetland 1 is an isolated, non-jurisdictional feature, not subject to regulation under Section 404 of the Clean Water Act (CWA).

Wetland 2 is a 0.291 acre emergent wetland located on site. Wetland 2 exhibits no connectivity to any apparent stream channel or jurisdictional water of the United States. The closest jurisdictional stream is an unnamed tributary to the Scioto River that is located approximately 1,410 linear feet southeast of Wetland 2. Wetland 2 would not support interstate or foreign commerce interests, nor does it contain any rare or endangered species. This office has determined that Wetland 2 is an isolated, non-jurisdictional feature, not subject to regulation under Section 404 of the CWA.

The site also contains 0.65 acre of two stormwater ponds. Stormwater Pond 1 (0.45 acre) and Stormwater Pond 2 (0.2 acre) were previously excavated in uplands for the purposes of Section 402 of the CWA and are not considered jurisdictional waters of the United States.

**C. SIGNIFICANT NEXUS DETERMINATION**

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not

appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
