Explain: **The 70 acre site contains features that have been evaluated for possible jurisdiction, including Open Water 1 (43.27 acres), Open Water 2 (13.46 acres), Open Water 3 (0.03 acre), Ditch 1 (52 linear feet [lf]), Swale 1 (34 lf), Swale 2 (68 lf), Swale 3 (34 lf), Swale 4 (24 lf), Swale 5 (44 lf), and Swale 6 (45 lf).**

The approved JD boundary includes 56.76 acres of non-jurisdictional features located on the subject site. Open Water 1 (43.27 acres) and Open Water 2 (13.46 acres) were previously created from aggregate mining operations onsite. Open Water 1 and Open Water 2 are surrounded by uplands and do not exhibit a distinct surface water connection to a water of the United States. Open Water 3 (0.03 acre) was not created as part of the aggregate mining. However, Open Water 3 is surrounded by uplands and does not exhibit a distinct surface water connection to a water of the United States. Additionally, Open Waters 1-3 exhibit no ordinary high water mark, defined bed and banks, or wetland characteristics. Therefore, Open Waters 1-3 are not jurisdictional waters of the United States.

The approved JD boundary also includes 301 lf of non-jurisdictional features located on the subject site. Ditch 1 is a 52 lf roadside ditch constructed wholly in and draining only uplands along an abandoned access road between Open Water 1 and Open Water 2. Ditch 1 does not carry a relatively permanent flow of water and lacks an ordinary high water mark. Ditch 1 does not exhibit a distinct surface water connection to a water of the United States. Swale 1 (34 lf), Swale 2 (68 lf), Swale 3 (34 lf), Swale 4 (24 lf), Swale 5 (44 lf), and Swale 6 (45 lf) are erosional features in the landscape that exhibit no ordinary high water mark, defined bed and banks, or wetland characteristics. Therefore, Ditch 1 and Swale 1-6 are not considered jurisdictional waters of the United States.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that directly abuts an RPW is also jurisdictional. If the aquatic resource is not a TNW, but has year-round (perennial) flow, skip to Section III.D.2. A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. Corps districts and EPA regions will include in the record any available information that documents the existence of a significant nexus between a relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not

appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
