- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: **The site contains three isolated wetlands (Wetland A, B and C, totaling 1.87 acres) that are located within the 25 acre project site. One intermittent UT to O'Bannon Creek flows through a portion of the site for approximately 428 linear feet. Wetlands A-C are located in depressions in the central portion of the site and there are no apparent hydrologic connections to the onsite stream or the tributary system of the TNW. These wetlands have no substantial nexus to interstate or foreign commerce. These wetlands are located in uplands, surrounded by uplands and lack a surface water connection to the tributary system of the Little Miami River. Wetlands A-C are not considered waters of the United States and are non-jurisdictional (Isolated) wetlands.**

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Wetlands A-C are not considered waters of the United States and are non-jurisdictional (Isolated) wetlands.
