commerce. The land surrounding this wetland consists of forested area to the west and active agricultural fields to the east. This feature does not have a distinct surface water connection to another potential water of the United States.

The closest jurisdictional stream is approximately 1,810 feet away. This feature would not support interstate or foreign commerce interest, nor does it contain any rare or threatened and endangered species. Therefore, this feature is not a jurisdictional water of the United States.

Wetland B (0.14 acre) is located in the northwestern portion of the property and is completely surrounded by uplands, with no surface water connection to a water of the United States, and no nexus to interstate or foreign commerce. The land surrounding this wetland consists of secondary growth forested area. This feature does not have a distinct surface water connection to another potential water of the United States. The closest jurisdictional stream is approximately 2,300 feet away. This feature would not support interstate or foreign commerce interest, nor does it contain any rare or threatened and endangered species. Therefore, this feature is not a jurisdictional water of the United States.

Wetland C (0.83 acre) is located in the western portion of the property and is completely surrounded by uplands, with no surface water connection to a water of the United States, and no nexus to interstate or foreign commerce. The land surrounding this wetland consists of secondary growth forested area and residential homes to the south. This feature does not have a distinct surface water connection to another potential water of the United States. The closest jurisdictional stream is approximately 2,700 feet away. This feature would not support interstate or foreign commerce interest, nor does it contain any rare or threatened and endangered species. Therefore, this feature is not a jurisdictional water of the United States.

Wetland E (0.56 acre) is located in the southern portion of the property and is completely surrounded by uplands, with no surface water connection to a water of the United States, and no nexus to interstate or foreign commerce. The land surrounding this wetland consists of scrub-shrub area and a roadway to the south. This feature does not have a distinct surface water connection to another potential water of the United States. The closest jurisdictional stream is approximately 845 feet away. This feature would not support interstate or foreign commerce interest, nor does it contain any rare or threatened and endangered species. Therefore, this feature is not a jurisdictional water of the United States.

Channel 1 (211 linear feet) forms naturally within the northeastern portion of the subject site. The feature flows in an eastern direction for approximately 211 linear feet before its defined features diminish and discharge into an active agricultural field. It was determined that this feature lacks a continuous surface water connection to tributary systems of a traditional navigable water. Therefore, this feature does not meet the criteria of a water of the United States in accordance with the definitions outlined in 33 CFR 328.3(a).

Swale 1 (350 linear feet) is drainageway or erosional features present within the site and is located entirely in uplands, lacks a defined bed and bank, an ordinary high water mark (OHWM), wetland characteristics, and therefore it is not a water of the United States.

Swale 2 (46 linear feet) is drainageway or erosional features present within the site and is located entirely in uplands, lacks a defined bed and bank, an ordinary high water mark (OHWM), wetland characteristics, and therefore it is not a water of the United States.

Swale 3 (439 linear feet) is drainageway or erosional features present within the site and is located entirely in uplands, lacks a defined bed and bank, an ordinary high water mark (OHWM), wetland characteristics, and therefore it is not a water of the United States.

Swale 4 (130 linear feet) is drainageway or erosional features present within the site and is located entirely in uplands, lacks a defined bed and bank, an ordinary high water mark (OHWM), wetland characteristics, and therefore it is not a water of the United States.

Swale 5 (213 linear feet) is drainageway or erosional features present within the site and is located entirely in uplands, lacks a defined bed and bank, an ordinary high water mark (OHWM), wetland characteristics, and therefore it is not a water of the United States.

Swale 6 (172 linear feet) is drainageway or erosional features present within the site and is located entirely in uplands, lacks a defined bed and bank, an ordinary high water mark (OHWM), wetland characteristics, and therefore it is not a water of the United States.

Swale 7 (270 linear feet) is drainageway or erosional features present within the site and is located entirely in uplands, lacks a defined bed and bank, an ordinary high water mark (OHWM), wetland characteristics, and therefore it is not a water of the United States.

Ditch 1 (39 linear feet) was excavated within uplands between 2009 and 2010 in association with a neighboring developments stormwater management system. This feature was constructed to serve as part of a drainage control treatment system

and is a rip-rap lined channel, lacks a defined bed and bank, an ordinary high water mark (OHWM), wetland characteristics, and therefore it is not a water of the United States..

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The feature flows in an eastern direction for approximately 211 linear feet before its defined features diminish and discharge into an active agricultural field. It was determined that this feature lacks a continuous surface water connection to tributary systems of a traditional navigable water. Therefore, this feature does not meet the criteria of a water of the United States in accordance with the definitions outlined in 33 CFR 328.3(a).

Ditch 1 (39 linear feet) was excavated within uplands between 2009 and 2010 in association with a neighboring developments stormwater management system. This feature was constructed to serve as part of a drainage control treatment system and is a rip-rap lined channel, lacks a defined bed and bank, an ordinary high water mark (OHWM), wetland characteristics, and therefore it is not a water of the United States..
