Explain: **The 13.7-acre site contains features that have been evaluated for possible jurisdiction, including Wetland A (0.37 acre), Wetland B (0.25 acre), Wetland C (0.18 acre), Wetland D (0.26 acre), and Open Water 1 (0.32 acre).**

The approved JD boundary includes Wetland A, a 0.37 acre scrub-shrub wetland, and Open Water 1, a 0.32 acre open water area. Wetland A is a shrub-dominated wetland occupying the fringe zone of a small open water pond in the study area. Wetland A surrounds Open Water 1 on all sides. Open Water 1 was excavated as a sediment control basin during construction of the East Liberty Plant (ELP) in the 1980s, but has since naturalized. The plant community in Wetland A is dominated primarily by hydrophytic shrub species, principally sandbar willow (*Salix interior*) and silky dogwood (*Cornus amomum*). The source of wetland hydrology for Wetland A is saturation and periodic inundation from Open Water 1. Wetland A and Open Water 1 are surrounded by uplands and do not exhibit a distinct surface water connection to a water of the United States. The closest jurisdictional stream is an unnamed tributary to Otter Creek that is located approximately 820 linear feet east of Wetland A and Open Water 1. Wetland A and Open Water 1 would not support interstate or foreign commerce interests, nor do they contain any rare, threatened, or endangered species.

The approved JD boundary includes Wetland B, a 0.25 acre emergent wetland. Wetland B is located within a slight depression that is periodically mowed field in the northern portion of the study area. The plant community in Wetland B is sparsely vegetated and dominated by soft rush (*Juncus effusus*). The source of wetland hydrology for Wetland B is ponding of surface runoff due to Wetland B's depressional position. Wetland B is surrounded by uplands and does not exhibit a distinct surface water connection to a water of the United States. The closest jurisdictional stream is an unnamed tributary to Otter Creek that is located approximately 314 linear feet east of Wetland B. Wetland B would not support interstate or foreign commerce interests, nor does it contain any rare, threatened, or endangered species.

The approved JD boundary includes Wetland C, a 0.18 acre emergent wetland. Wetland C is located within a slight depression in the same mowed field as Wetland B, but Wetland C is located further south within the study area. The plant community in Wetland C is sparsely vegetated and dominated by yellow foxtail (*Setaria pumila*) and soft rush (*Juncus effusus*). The source of wetland hydrology for Wetland C is ponding of surface runoff. Wetland C is surrounded by uplands and does not exhibit a distinct surface water connection to a water of the United States. The closest jurisdictional stream is an unnamed tributary to Otter Creek that is located approximately 336 linear feet east of Wetland C. Wetland C would not support interstate or foreign commerce interests, nor does it contain any rare, threatened, or endangered species.

The approved JD boundary includes Wetland D, a 0.26 acre forested wetland. Wetland D is located within a depression in a tree line running northwest to southeast through the approximate center of the study area. The plant community in Wetland D is dominated by American elm (*Ulmus americana*) in the tree layer, grey dogwood (*Cornus racemosa*) and bush honeysuckle (*Lonicera sp.*) in the shrub layer, and an unknown sedge species (*Carex sp.*) in the herbaceous layer. The source of wetland hydrology for Wetland D is ponding of surface runoff. Wetland D is surrounded by uplands and does not exhibit a distinct surface water connection to a water of the United States. The closest jurisdictional stream is an unnamed tributary to Otter Creek that is located approximately 448 linear feet east of Wetland D. Wetland D would not support interstate or foreign commerce interests, nor does it contain any rare, threatened, or endangered species.

This office has determined that Wetlands A, B, C, D and Open Water 1 are isolated, non-jurisdictional features, and not subject to regulation under Section 404 of the Clean Water Act (CWA).

If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
