The approved JD boundary includes Wetland B, a 0.01 acre forested wetland. Wetland B is located within a closed depression in a woodlot in the northeast corner of the study area. The plant community in Wetland B is dominated primarily by American elm (*Ulmus americana*) saplings and green ash (*Fraxinus pennsylvanica*) saplings. Wetland B had approximately 5-inches of surface water. Wetland B is surrounded by uplands and does not exhibit a distinct surface water connection to a water of the United States. The closest jurisdictional stream is Hayden Run that is located approximately 483 linear feet north of Wetland B. Wetland B would not support interstate or foreign commerce interests, nor does it contain any rare, threatened, or endangered species.

The approved JD boundary includes Wetland C, a 1.67 acres emergent wetland. Wetland C is located within a closed depression in the southwest corner of the study area. The plant community in Wetland C is primarily dominated by bluegrass (*Poa sp.*) and purpleleaf willowherb (*Epilobium coloratum*). Wetland C appears to continue offsite. Wetland C has approximately 3-inches of surface water. Wetland C is surrounded by uplands and does not exhibit a distinct surface water connection to a water of the United States. The closest jurisdictional stream is Hayden Run that is located approximately 4,774 linear feet west of Wetland C. Wetland C would not support interstate or foreign commerce interests, nor does it contain any rare, threatened, or endangered species.

The approved JD boundary includes Wetland D, a mixed emergent (0.07 acre) and scrub-shrub (0.03 acre) wetland. Wetland D is located within a closed depression in an isolated patch of trees near the northeast boundary of the study area. The plant community in Wetland D is primarily dominated by reed canary grass (*Phalaris arundinacea*), buttonbush (*Cephalanthis occidentalis*), and box elder (*Acer negundo*). Wetland D is surrounded by uplands and does not exhibit a distinct surface water connection to a water of the United States. The closest jurisdictional stream is Hayden Run that is located approximately 950 linear feet west of Wetland D. Wetland D would not support interstate or foreign commerce interests, nor does it contain any rare, threatened, or endangered species.

This office has determined that Wetlands B, C, and D are isolated, non-jurisdictional features, and not subject to regulation under Section 404 of the Clean Water Act (CWA).

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. Corps districts and EPA regions will include in the record any available information that documents the existence of a significant nexus between a relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

If the waterbody<sup>4</sup> is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. If the JD covers a tributary with adjacent wetlands, complete Section III.B.1 for the tributary, Section III.B.2 for any onsite wetlands, and Section III.B.3 for all wetlands adjacent to that tributary, both onsite and offsite. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
