The approved JD boundary includes Wetland A, a 0.037 acre emergent wetland located in a depression in the southwest portion of the study area. The plant community in Wetland A is dominated by woolgrass (*Scirpus cyperinus*) and rushes (*Juncus effusus* and *Juncus tenuis*). The source of wetland hydrology for Wetland A is sheet flow from the surrounding landscape. Wetland hydrology within Wetland A included standing water, soil saturation at the surface, a shallow water table, and sediment deposits. The soil sample located within Wetland A (SP-2) exhibited the hydric soil indicator of a depleted matrix. Wetland A is surrounded by uplands and does not exhibit a distinct surface water connection to a water of the United States. The closest jurisdictional stream is an unnamed tributary to Alum Creek that is located approximately 3,806 linear feet west of Wetland A. Wetland A would not support interstate or foreign commerce interests, nor does it contain any rare, threatened, or endangered species.

The approved JD boundary includes Wetland B, a 0.093 acre emergent wetland located in a depression in the southwest portion of the study area. The plant community in Wetland B is dominated by narrow leaf cattail (*Typha angustifolia*). The source of wetland hydrology for Wetland B is sheet flow from the surrounding landscape. Wetland hydrology within Wetland B included standing water, soil saturation at the surface, and a shallow water table. The soil sample located within Wetland B (SP-4) exhibited the hydric soil indicator of a depleted matrix. Wetland B is surrounded by uplands and does not exhibit a distinct surface water connection to a water of the United States. The closest jurisdictional stream is an unnamed tributary to Alum Creek that is located approximately 3,869 linear feet west of Wetland B. Wetland B would not support interstate or foreign commerce interests, nor does it contain any rare, threatened, or endangered species.

The approved JD boundary includes Wetland C, a 0.441 acre emergent wetland located in a depression in the southeast portion of the study area. The plant community in Wetland C is dominated by common rush (*Juncus effusus*) and calico aster (*Symphotrichum lateriflorum*). The source of wetland hydrology for Wetland C is sheet flow from the surrounding landscape. Wetland hydrology within Wetland C included standing water, soil saturation at the surface, and a shallow water table. The soil sample located within Wetland C (SP-5) exhibited the hydric soil indicator of a depleted matrix. Wetland C is surrounded by uplands and does not exhibit a distinct surface water connection to a water of the United States. The closest jurisdictional stream is an unnamed tributary to Alum Creek that is located approximately 3,932 linear feet west of Wetland C. Wetland C would not support interstate or foreign commerce interests, nor does it contain any rare, threatened, or endangered species.

The approved JD boundary includes Wetland D, a 0.077 acre emergent wetland located in a depression in the south central portion of the study area. The plant community in Wetland D is dominated by calico aster (*Symphotrichum lateriflorum*) and broom sedge (*Carex tribuloides*). The source of wetland hydrology for Wetland D is sheet flow from the surrounding landscape. Wetland hydrology within Wetland D included standing water and soil saturation at the surface. The soil sample located within Wetland D (SP-7) exhibited the hydric soil indicator of a depleted matrix. Wetland D is surrounded by uplands and does not exhibit a distinct surface water connection to a water of the United States. The closest jurisdictional stream is an unnamed tributary to Alum Creek that is located approximately 4,015 linear feet west of Wetland D. Wetland D would not support interstate or foreign commerce interests, nor does it contain any rare, threatened, or endangered species.

The approved JD boundary includes Wetland E, a 0.116 acre emergent wetland located in a depression in the south central portion of the study area. The plant community in Wetland E is dominated by calico aster (*Symphotrichum lateriflorum*) and broom sedge (*Carex tribuloides*). The source of wetland hydrology for Wetland E is sheet flow from the surrounding landscape. Wetland hydrology within Wetland E included standing water and soil saturation at the surface. The soil sample located within Wetland E (SP-9) exhibited the hydric soil indicator of a depleted matrix. Wetland E is surrounded by uplands and does not exhibit a distinct surface water connection to a water of the United States. The closest jurisdictional stream is an unnamed tributary to Alum Creek that is located approximately 4,003 linear feet west of Wetland E. Wetland E would not support interstate or foreign commerce interests, nor does it contain any rare, threatened, or endangered species.

The approved JD boundary includes Wetland F, a 0.023 acre emergent wetland located in a depression in the south central portion of the study area. The plant community in Wetland F is dominated by reed canary grass (*Phalaris arundinacea*). The source of wetland hydrology for Wetland F is sheet flow from the surrounding landscape. Wetland hydrology within Wetland F included standing water and soil saturation at the surface. The soil sample located within Wetland F (SP-11) exhibited the hydric soil indicator of a depleted matrix. Wetland F is surrounded by uplands and does not exhibit a distinct surface water connection to a water of the United States. The closest jurisdictional stream is an unnamed tributary to Alum Creek that is located approximately 4,216 linear feet west of Wetland F. Wetland F would not support interstate or foreign commerce interests, nor does it contain any rare, threatened, or endangered species.

This office has determined that Wetlands A, B, C, D, E, and F are isolated, non-jurisdictional features, and not subject to regulation under Section 404 of the Clean Water Act (CWA).

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. Corps districts and EPA regions will include in the record any available information that documents the existence of a significant nexus between a relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
