- B. Typical year assessment(s):** A typical year occurs over a rolling thirty year period and includes the analysis of precipitation and other climatic variables to establish a normal period range (seasonally or annually) for a specific geographic region where the aquatic resource occurs. One point-in-time data source, 10 September 2018 , with a corresponding APT report, were included in the evaluation for the excluded features onsite. The antecedent precipitation tool was utilized to determine typical year for point-in-time data sources. Wetland adjacency was assessed on 10 September 2018. Based on the antecedent precipitation tool, 10 September 2018 is included during the WebWIMP dry season and has a Palmer Drought Severity Index of severe wetness. The 30-day rolling total for precipitation was wetter than normal compared to the 30-year average. With an wetter than normal year the onsite wetlands had no connection to an (a)(1)-(a)(2) water.
- C. Additional comments to support AJD:** The property is located outside of the FEMA 100 year floodplain.
