B. Typical year assessment(s): A typical year occurs over a rolling thirty year period and includes the analysis of precipitation and other climatic variables to establish a normal period range (seasonally or annually) for a specific geographic region where the aquatic resource occurs. One (1) point-in-time data source dated 20 October 2020, with a corresponding antecedent precipitation tool (APT) report, is included in the evaluation for the excluded features listed in Section II D. According to the APT report for 20 October 2020, wetter than normal conditions with an antecedent precipitation condition score of 11 was
