B. Typical year assessment(s): A typical year occurs over a rolling thirty year period and includes the analysis of precipitation and other climatic variables to establish a normal period range (seasonally or annually) for a specific geographic region where the aquatic resource occurs. One point-in-time data sources, one for December 22, 2020, with a corresponding APT report, were included in the evaluation for the excluded streams listed in Section II D (Ditch 1, Swale 1 & Swale 2). According to the APT report of December 2020, wetter than normal conditions were observed during the wet season with a PSDI Value of 0.72 (incipient wetness) and an ARC score of 15. The antecedent precipitation condition is considered “wetter than normal” for that point in time. Additionally, during the based on the pictures submitted with the Report, during wetter than normal conditions in the wet season, little flow or no flow was observed, supporting the fact that the ephemeral streams do not meet the flow requirements of a jurisdictional tributary. It has been determined that the ephemeral streams listed in Section II D, above, exhibit ephemeral flow, and are not waters of the United States per 33 CFR 328.3(b)(3), and are not subject to regulation under Section 404.
