[The review area is approximately 183 acres \(ac\) of industrial development, stormwater management facilities, and open/forested areas along WV Route 62 near Buffalo, in Putnam County, West Virginia.](#)

The 183 (ac) site contains features that have been evaluated for possible jurisdiction, including 10,790.6 linear feet (lf) of twenty (20) intermittent and ephemeral features (NPDES UNT 3, 3A, 4-12, 13-18) and 2.25 ac of three (3) open water features (NPDES Pond 1, 2, and 3). The closest jurisdictional stream is an unnamed tributary to the Kanawha River, an indirect tributary to the Kanawha River.

The aforementioned features are industrial stormwater features and are permitted under the West Virginia's Multi-Sector Stormwater National Pollutant Discharge Elimination System (NPDES) General Permit No. WV0111457, Registration No. #WVG611182. As such, these waters are designated and designed for the purposes defined by Section 402 of the Clean Water Act (CWA) and are not considered jurisdictional waters of the United States. These features are not subject to regulation under Section 404 of the CWA.

The approved JD boundary includes non-jurisdictional reaches of twenty (20) features (UNT 3, 3A, 4-12, 15A, 16, and 17A), totaling 10,790.6 lf, and three (3) open water features (NPDES Stormwater Ponds 1-3), totaling 2.25 ac, are permitted under Section 402 of the CWA and are not considered jurisdictional features.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not

appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
